#### Health Care News:

Open enrollment (the yearly period when you can enroll in a health plan) for 2017 runs from November1, 2016 to January 31st, 2017. Now is the time to review your plan and make any needed changes. If you don't enroll by January 31st, you can't enroll in a health insurance plan for the rest of 2017 unless you qualify for a Special Enrollment Period.

Snowmobile Insurance: Can provide coverage for personal injury, damages to the machine, as well as your legal <u>liability</u> in the event that you are responsible for another person's injuries or property damage. In North Dakota there are four types of required auto coverage. They are liability, uninsured motorist, underinsured motorist and personal injury protection. Our agency feels it is important to provide information to our clients, and refresh their knowledge on products. This December newsletter we will go over PIP (personal injury protection), sometimes referred to as no-fault. PIP coverage pays for personal injuries and medical expenses incurred by you and your family members if they are accidentally injured in a car accident. It may also pay for lost wages if the injured person needed hospital care, survivors' income loss and burial expenses. Specific dollar amounts apply to these coverages. The medical expenses are based on the reasonable and customary charges as determined by medical necessity. The minimum amount that is required by insurance companies in North Dakota for no-fault for any one person for any one accident is \$30,000. Coverage requirements are minimums. You are able to purchase higher liability limits. Your policy terms will tell you how much coverage is available and what types of expenses it will cover.



When an accident happens, there are a lot of things to think about. One being how am I getting to work tomorrow? If you have rental coverage as part of your auto policy this question will be easier. Rental coverage helps you pay to rent a car if your vehicle is getting repaired. As you make this decision think about whether you could afford to pay out of pocket for a rental car. Keep in mind there is usually a per-day limit and limit on number of days for which an amount will be reimbursed for a rental car.

Another inexpensive coverage to consider before an emergency occurs is Roadside Assistance. Depending on the company most things covered would be: 1.Towing-to the nearest repair facility. 2. Flat tire change. 3 .Battery jump-start. 4. Emergency fuel and fluid deliver. Customers pay only for the fuel or fluids. Delivery service is free. 5. Locksmithing-Service providers will get customers back in the car and on their way. Customer will only have to pay for the cost of the keys.

#### **CROP INSURANCE:**

#### RIDE, CAR AND HOME SHARING:

Ride sharing is now available in more than 250 cities. Ride-sharing is the service provided by companies like Lyft and Uber. Car-sharing allows you to temporarily rent out your otherwiseparked car for a limited period of time. Ride and Car Sharing are considered business as money is exchanged. A personal auto policy does not cover an insured when the vehicle is used in business pursuits. Home sharing is expanding, renting out your home on a short-term basis may seem like an easy way to earn cash. Typically your homeowners' insurance policy will not cover losses arising from business ventures.
